#### **Architectural Committee:**

Lot#74, 1851 Springwood Circle S requested roof replacement. Approved. Phil will send out notice to homeowners of Lots#78 and 80, who have built unapproved fences in their yards. Motion to approve by Micheal Andres; 2<sup>nd</sup> by Mary Lou Quinn. Approved unanimously.

#### **Management Company Report:**

After Phil's August inspection, 24 violation letters were sent out. Most common violations: trash cans left out, weeds, yards without 50% greenery per City of Clearwater code, and homes in need of pressure washing/painting. Letter will be sent o Lot# 161, 2233 Springwood Circle W about the pine needle issue. They will be given a chance to fix the problem, or we may have to take legal action, as this issue has

become a potential liability, if someone is injured by slipping on pine needles on the sidewalk and/or street . Phil will be doing October inspection soon. Duke Energy fixed one street light at Virginia Ave entrance, but needs to be contacted to fix other light at that entrance. Light at Keene entrance has been repaired. Phil will look into getting the trees trimmed, that are hanging over the neighborhood streets. He will also remind our landscapers that they are NOT to trim the palm trees; and they are to remove any debris they have created as a result of their approved landscaping . Also, they should let us know if they see yard debris, which has been thrown over the fence by homeowners, so we can address the issue. Phil also reported that the spa heater will be repaired.
